**Assumption of Risks:** Physical activity, by its very nature, carries with it certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. The specific risks vary from one activity to another, but the risks range from: 1) minor injuries such as scratches, cuts, bruises, strains, and sprains 2) major injuries such as eye injury or loss of sight, major joint or back injuries, major blood loss, bone fractures, heart attacks, strokes, and concussions to 3) catastrophic injuries including paralysis and death.
